Winnipeg Sketch Club 107th Juried Exhibition

CALL FOR SUBMISSIONS

Community Gallery 2nd Floor, The Pavilion, Assiniboine Park
Show opens Saturday, Dec. 5th and continues until February of 2027

Members may enter up to 3 two-dimensional pieces: maximum 36" wide 48" high. There is a non-refundable entry/judging fee of **\$20 per piece** entered.

Our juror this year is **Laura Lewis**. The juror will select works to be shown in the exhibition from those entered and will also select prize winners—Judge's Choice, (best overall) and 3 runners-up.

All work accepted into the exhibition must be dry and ready for hanging. Ready for hanging means that it must have a wire on the back and a stable frame. All work must be labelled on the back with the title, the medium, the artist's name, and the price, if it's for sale. The Club assumes no responsibility for works lost, stolen or damaged. The Sketch Club takes a 20% commission on all sales and 15% of that goes to the gallery.

Only Sketch Club members that have paid their dues for 2026 can enter works.

All work submitted must be original, must not be more than three years old, and must not have been included in previous WSC Annual Juried Exhibitions. Any work submitted that does not meet these requirements will not be accepted. In addition, any work deemed unacceptable by the Community Gallery will not be shown.

Additional Prizes:

Lynn Sissons Award - The Lynn Sissons Award is decided on by a committee of sketch club members who have not entered work in the show. It is meant to encourage the continued appreciation of traditional watercolour painting as practised by the late Lynn Sissons who was a long time Sketch Club member and internationally known watercolourist. This prize is paid for by a fund bequeathed to the Winnipeg Sketch Club by Ms Sissons.

The Peoples' Choice Award will be presented following the show and is decided by votes cast by the anyone who visits the show during its run.

Make sure all work is labelled on the back with the title, medium, artist's name and the price, if it's for sale.

Saturday, Nov. 28th (Same day as above) Artists will be notified by email or phone if their piece/s have not been juried into the Exhibit. Pick up art between 3:00-4:00 p.m.

Saturday, Dec 5th Official Show Opening Reception 1:30 - 3:30 p.m. at the Pavilion. The juror will speak and prize winners will be announced.

February of 2027 Show closes. Exact date TBA.

February of 2027 Exact date TBA. Artwork will be available at the Pavilion for artists to pick up from noon until 2:00 p.m.. Artwork may **not** be picked up earlier.
